Dear Delaware Tribal Member, Interested Parties, et all:

I am writing this letter and hoping it finds you in excellent health and spirits. I am reaching out to you personally to inform you of the petitions I filed for the recall and removal of Delaware Tribal Assistant Chief Bonnie Jo Griffith and Councilman Nathan H. Young as well as relevant evidentiary support from the Delaware Tribe of Indians Tribal Constitution & Bylaws, and the Delaware Tribe of Indians Code of Conduct / Code of Ethics. The petitions have been filed with the Tribal Council Secretary & Councilwoman Annette Ketchum.

The basics of the petitions are as follows:

- 1. To recall the election and removal of office for Delaware Tribal Assistant Chief Bonnie Jo Griffith and Councilman Nathan H. Young,
- 2. To terminate the salaries of Delaware Tribal Assistant Chief Bonnie Jo Griffith and Councilman Nathan H. Young effective immediately;
- 3. To prohibit Delaware Tribal Assistant Chief Bonnie Jo Griffith and Councilman Nathan H. Young, from holding any elected or appointed position with the Delaware Tribe of Indians in the future;
- 4. To prohibit the Tribal Council of the Delaware Tribe of Indians from reinstating their salaries, offices, any other positions, or their employment for any reason in the future,
- 5. And to prohibit the Delaware Tribe of Indians or any of its affiliated branches or businesses from hiring either of Delaware Tribal Assistant Chief Bonnie Jo Griffith and Councilman Nathan H. Young in any capacity in the future.

There are numerous alleged reasons listed on these petitions for recall and removal, and I wish to provide you the unbiased information and not hearsay. This letter is intended to cite the tribally approved documents, various sources, and evidence that I believe supports my allegations.

My purpose is to be the spot light that:

- enables Delaware Tribal Members to read for their self the allegations and evidence.
- empowers Delaware Tribal Members to make informed decisions on specific allegations,

• and show alleged violations of the <u>Delaware Tribe of Indians Constitution</u> and <u>Bylaws</u>, and <u>Code of Conduct</u> / <u>Code of Ethics</u>.

Please note that this listing of allegations and/or violations of federal, tribal and/or state regulations, policies, and laws as well as evidentiary support are incomplete at the date of this publication. I reserve the right to publish additional listings of allegations and/or violations of federal, tribal and state regulations, policies, and laws. Additionally I reserve the right to publish additional evidentiary supporting documents as it is provided to me, and as research as well as time allows.
