Dear Delaware Tribe of Indians Tribal Member:

The allegations supporting the recall and removal of office for Delaware Tribe of Indians Assistant Chief /Tribal Councilwoman Bonnie Jo Griffith and Councilman Nathan H Young at this time are as follows:

1. Charges on Abuse of Authority – Alleged use of: elected office for self gain or special interests, fraud, influence/harassment/or intimidation of Tribal Members, dishonesty, unethical, and unprofessional behavior.
2. Charges on Crimes of Dishonesty – Alleged use of: fraud, influence/harassment/or intimidation of Tribal Members, dishonesty, unethical, and unprofessional behavior.
3. Charges on Interfering with Tribal Council Members and Officer duties – Alleged use of: influence/harassment/or intimidation of Tribal Members, dishonesty, unethical, unprofessional behavior, violations of Roberts Rules of Order.
4. Charges on Using her/his office wrongly &/or for personal gain - Alleged use of: elected office for self gain or special interests, fraud, theft, influence/harassment/or intimidation of Tribal Members, dishonesty, unethical, and unprofessional behavior.

The purpose of this letter is to provide a general overview of the allegations I am making to recall and remove from office Delaware Tribe of Indians Assistant Chief /Tribal Councilwoman Bonnie Jo Griffith and Councilman Nathan H Young. Please note that this listing of alleged: crimes and/or violations of federal, tribal and state regulations, policies, and laws, in addition to evidentiary support is incomplete at the time of this publishing. I reserve the right to publish additional listings of alleged: crimes and/or violations of federal, tribal and state regulations, policies, and laws, in addition to reserving the right to publish additional evidentiary supporting documents as time and alleged evidence of wrong doing allows. I wish to express my gratitude that you have chose to spend your time reading and deciding for yourself if you will sign the petitions for recall and removal of Bonnie Jo Griffith and Nathan H.
